School Access Route Plan

Maple Grove Middle School 2024-2025

In accordance with state standards, Maple Grove Middle School has identified school access routes for school students who live within the walk boundary established for the school. A map showing the identified routes can be viewed by following the link below. Link to - MGMS School Access Route Plan Map.

The intent of a School Access Route Plan is not to identify every school access route or to identify the more convenient school access routes; it is to identify main walk/bike routes that appear to be secure. Care has been taken to consult with local law enforcement, school PTA and School Community Council representatives, and the district's traffic safety committee in establishing these school access routes. Despite broad consultation and unanimous agreement from all parties involved in establishing these routes, no one, including the Nebo School District and Maple Grove Middle School can guarantee that the agreed upon school access routes are or will ever be completely free from hazards.

Parents are encouraged to walk or bike the school access routes with their child/children, to address specific concerns they may have, and to instruct their child/children to obey the laws and rules pertaining to pedestrian safety. If a parent feels their child/children should use a school access route that is not identified in this plan, it is their prerogative to instruct their child/children as to what they feel is best for them.

As previously stated, the intent of a School Access Route Plan is not to identify every school access route or to identify the more convenient school access routes. For this plan, school access routes leading to the school from areas where clusters of students live, have been identified and are described below.

School Access Route Description:

Area 1: East of 1600 West (Hwy. 89) and north of 800 South (purple lines on the map)

Students can access MGMS by following the indicated routes southward to 1200 North then west to 800 W. and turn toward the school at 400 S and access the northwest side of the property.

From Maple Street continue west to 800 W. and turn toward the school at 400 S and access the school on the northwest side of the property.

Area 2: East of 1600 West (Hwy 89) and south of 800 South (blue lines on the map)

Students should access MGMS by following indicated routes along 1600 S until reaching 1030 W turning north on 1030 W. Continue to 1200 Sand turn left until reaching 1200 W, turn right and continue northward until reaching 400 S, turn left and access the school on the northwest side of the property.

Area 3: West of 1600 West (Hwy. 89) and north of 1600 S (orange lines on the map -AKA Harvest Park)

Students should access MGMS by following indicated routes leading to Harvest Parkway. Turn east on Harvest Parkway and continue to the traic signal on the corner of 1600 W (Hwy 89) and Harvest Parkway. Cross 1600 W. at the signal and turn north on the east side of the street continuing northward and access the school from the southwest corner of the property.

Area 4: West of 1600 West (Hwy. 89) and south of 1600 S (red lines on the map)

Students should access MGMS by following indicated routes on the west side of 1600 West (Hwy. 89) heading north. At the traic signal on the corner of 1600 South and 1600 West (Hwy. 89) head east on 1600 S and continue to 1450 W. Turn north on this street and continue until reaching 1200 S. Turn east and continue until reaching 1200 W. Turn right and continue northward until reaching 400 S, turn left and access the school on the northwest side of the property.
